## MAJOR AWARD FEATURED AT EXTENDED HOUSING, INC.'S 2018 ROCK THE HOUSE FUNDRAISING EVENT

\$100,000 in "Cy Pres" Funds Distributed by Dworken & Bernstein Co., L.P.A.

**PAINESVILLE, OH, NOVEMBER 14, 2018** An unanticipated award highlighted Extended Housing, Inc.'s *Rock the House* fundraiser last month. Ric Selby, a partner in the law firm of Dworken & Bernstein Co., L.P.A., presented Karen McLeod, the executive director of Extended Housing, Inc., with a giant check, representing the distribution of one hundred thousand dollars to the nonprofit. The source of the money was unclaimed funds from a class action lawsuit settlement. The event also raised nearly thirty-five thousand dollars in individual donations and corporate sponsorships.

Two hundred and fifty people were in attendance at the event, which was held on October 5, 2018 at the Normandy Party Center in Wickliffe. Ricky & The Rockets provided musical entertainment and Q104's Amanda Morales served as the emcee for the evening.

Many attendees came dressed as their favorite rock star and there were some stellar entrants in the costume contest. The event raised funds for the nonprofit in several ways, including a "Rock Raffle" for several prize baskets, sideboards, and raffles for several special items, including a Cancun vacation. The evening's silent auction featured a heavy metal guitar made by students at the Auburn Career Center. A new attraction at this year's event was a photo booth.

McLeod stated, "Ohio Lawyers Give Back blew Extended Housing away at our *Rock the House* fundraiser on October 5, 2018! Thank you, Dworken & Bernstein, for your continued fight to help nonprofits!
